ASSYST is a low-use-rate, activator adjuvant blend designed to maximize the performance of glyphosate, and its tank mix partners, on hard-to-control weed species. ASSYST effectively replaces the need for ammonium sulfate with glyphosate and glyphosate tank mixes by sequestering antagonistic hard water ions, maximizing cuticle penetration of both water-soluble and oil-soluble herbicides, and protonating weak acid herbicides for rapid absorption and transportation.

USE RATES

Apply ASSYST at 0.5-0.75% v/v (2-3 quarts per 100 gallons of spray solution).

While the water is agitating, add tank mix ingredients in the following order: 1. Water-soluble packets, dry flowables and dispersible granule pesticides. 2. Flowable pesticides. 3. ASSYST. 4. Water-soluble pesticides. 5. Emulsifiable concentrate pesticides. 6. Finish filling spray tank to desired level and continue agitation.
