STATEMENT OF PRACTICAL TREATMENT

If Swallowed: If victim is fully conscious give large quantities of water to drink. Never attempt to give fluids if the person is unconscious or is having convulsions.

If In Eyes: Flush with water for 15 minutes. Seek medical attention immediately.

If On Skin: Wash skin contact area with plenty of soap and water for 15 minutes.

GENERAL INFORMATION

EXTRA POINT is a liquid activator adjuvant specifically formulated to maximize pesticide performance on a wider range of weed species by eliminating spray particle bounce and reducing drift, thus providing superior adhesion of the spray solution to the leaf surface, while providing the required amount of ammonium and sulfate ions.

DIRECTIONS FOR USE

FOR USE WITH PESTICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NON-CROPLAND, RIGHTS-OF-WAY AND OTHER APPROPRIATE USES.

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using EXTRA POINT, the applicator or crops advisor must have experience with the pesticide combination, including EXTRA POINT, or must have conducted a phytotoxicity test.

USE RATES

Ground Application: Apply EXTRA POINT at 2.5% v/v (2.5 gallons per 100 gallons of spray solution).

Aerial Application: Apply EXTRA POINT at 2.5–5% v/v (2.5–5 gallons per 100 gallons of spray solution).

MIXING INSTRUCTIONS

Always mix this product in accordance with the instructions found on the pesticide label concerning adjuvants. In the absence of specific mixing instructions, fill the spray tank 3/4 full of desired water volume. While the water is agitating, add tank mix ingredients in the following order: 1. EXTRA POINT. 2. Water-soluble packets, dry flowables and dispersible granules. 3. Flowables. 4. Water-soluble pesticides. 5. Emulsifiable concentrates. Continue agitation and finish filling spray tank to desired level. 6. Add additional adjuvants.

STORAGE AND DISPOSAL

Store in original container only and do not reuse empty container. Dispose of the container in accordance with federal, state and local regulations.
