Liquid Foliar Spray

PRODUCT INFORMATION

Dyna Green MZ is a liquid foliar formulation designed for maximum uptake of zinc and manganese and should correct and prevent deficiencies in most citrus. If added to the spray tank first, it will aid in lowering water pH. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and / or urea nitrogen will aid in uptake.

CROP RECOMMENDATIONS

Citrus & Fruit Crops: Mature trees: Apply 2-3 quarts per acre per application in enough water to cover. Repeat applications in summer and fall sprays as needed. **Young trees:** Apply 2 quarts per 100 gallons of water and wet thoroughly. **Pecans:** Apply 2-3 quarts per acre in enough water to cover.

DIRECTIONS FOR USE

Dyna Green MZ should be applied at 2-3 quarts per acre in enough water to cover. **Aerial applications:** 1-2 quarts per acre in a minimum of 5 gallons of water per acre.

PRECAUTIONS

Avoid getting in eyes, mucous membranes or on skin. Use with adequate ventilation. Keep container capped when not in use. **KEEP OUT OF REACH OF CHILDREN.** Do not contaminate feed, seed or water supplies. The use of side-shielded safety glasses is recommended.

FIRST AID
