POTATO MIX Liquid Foliar Spray

PRODUCT INFORMATION

Dyna Green Potato Mix is a liquid foliar formulation designed to correct and prevent magnesium, sulfur and micronutrient deficiencies in solanaceous crops. If added to the spray tank first, it will aid on lowering the water pH. A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant will aid in surface coverage which will help leaf absorption.

CROP RECOMMENDATIONS

Potatoes: Use 2 to 3 quarts per acre per application in enough water to allow for thorough coverage but not to run off. Repeat applications as needed.

Vegetables and Row Crops: Use 2 to 3 quarts per acre per application in enough water to allow for thorough coverage but not run off. Repeat applications as needed.

Other crops: Use lower rates of 1 to 4 pints per acre in enough water to allow for thorough coverage but not run off. Repeat in 2 to 4 applications.

Turf, Greens, & Tees: Apply 4 to 6 ounces per 1000 square feet in enough water to cover. Repeat as needed.

DIRECTIONS FOR USE

Dyna Green Potato Mix should be applied at 2 to 3 quarts per application in 100 gallons of water per acre. **Aerial application:** 2 quarts per acre in 5 to 10 gallons of water per acre.

WARNING
