PRODUCT INFORMATION

Dyna Gold Zinc is a liquid foliar formulation designed to correct and prevent zinc deficiencies in most crops. The addition of a non-ionic surfactant will aid surface coverage, which will help in leaf absorption.

CROP RECOMMENDATIONS

Citrus, Fruit Crops and Pecans: Use 1 to 2 quarts per acre per application in 50 to 100 gallons of water per acre.

Vegetable Crops (including beans, cabbage, cantaloupe, celery, cucumber, eggplant, endive, lettuce, greens, peas, melons, pepper, potatoes, squash, strawberries, sweet corn and tomatoes): Apply 1 to 2 quarts per acre in weekly applications as needed up to first harvest. **DO NOT USE ON STONE FRUITS.**

DIRECTIONS FOR USE

Dyna Gold Zinc should be applied as needed starting with the first spray at 1 to 2 quarts per acre in enough water to allow for thorough coverage.

Aerial application: Apply the product in adequate water to ensure proper mixing and coverage.

A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application.
