### GENERAL INFORMATION

**ACTIVATOR** is a water soluble spreader-activator non-ionic type surfactant designed for use in improving wetting and deposition of pesticide spray on leaf surfaces. **ACTIVATOR** decreases the surface tension of the spray droplets allowing for increased spreading and more uniform coverage on leaf and stem surfaces.

### USE DIRECTIONS

**ACTIVATOR** can be used with agricultural, industrial, forestry, aquatic and turf products that recommends a wetter-spreader type adjuvant. Add pesticides and other related products to the spray mixture before adding **ACTIVATOR**.

NOTE: Always follow pesticide label recommendations.

• **HERBICIDES:** **ACTIVATOR** is recommended for use at a rate of 0.5 to 2 pints per 100 gallons of spray with most post emergence herbicides which recommend the use of a non-ionic surfactant (unless otherwise directed by the herbicide manufacturer).

• **DEFOLIANTS:** **ACTIVATOR** is recommended for use at a rate of 2 pints per 100 gallons of spray when applied at a application rate of 10 or more gallons per acre. Use a rate of 4 pints per 100 gallons when the application is less than 10 gallons per acre.

• **INSECTICIDES, FUNGICIDES AND ACARACIDES:** **ACTIVATOR** is recommended at a rate of 2 to 8 ounces per 100

gallons of spray to enhance the wetting of insecticides, fungicides or acaricides.

• **SOIL PENETRANT: ACTIVATOR** should be applied at a rate of 8 ounces per 1,000 square feet of turf. Applications should be made in a minimum spray volume of 12 gallons of water per acre.

#### **STORAGE AND DISPOSAL**

Do not store near heat or open flame. Store in original container. Do not reuse empty container. Triple rinse (or equivalent) into spray tank then dispose of or recondition container through the regulations set by local and state authorities.

#### **CAUTION**
