Norway and Roof Rats: Apply 2-8 place packs (usually at intervals of 15-30 ft.) per placement. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease. Two place packs contain enough bait (100 g) to kill 1-3 rats.

House Mice: Open pack and apply ¼ - ½ oz. of bait per placement. Space placements at intervals of 8-12 ft. Larger placements (up to 2 oz.) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

Rats and Mice: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead rodents and left over bait properly. To prevent reinfestation, limit source of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, maintain permanent bait stations and replenish with census or toxic bait as needed.
