Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles (ships, trains, aircraft), docks and port of terminal buildings and related structures around and associated with these sites. Fence and perimeter bait, beyond 100 feet from any structure as defined above, is prohibited. This product must not be applied directly to food or feed crops.

Burrow baiting with Ramik® Mini Bars is prohibited.

Do not place near or inside ventilation duct openings. **NORWAY AND ROOF RATS:** Apply 4 to 16 one-ounce Ramik<sup>®</sup> Mini Bars per placement. Space placements at intervals of 15 to 30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there no longer are signs of new feeding by rats.

HOUSE MICE: Place one 1-ounce Ramik® Mini Bar at each placement location. Space placements at 8- to 12-foot intervals. Placement of two 1-ounce pieces each may be needed at points of very high house mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there no longer are signs of new feeding by house mice.

**FOLLOW-UP:** Replace contaminated or spoiled bait immediately. Using waterproof gloves collect and dispose of all dead, exposed animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
