APPLICATION AND MIXING GUIDE

Application rates for general use are 2-6 gallons per acre. Foliar Application Rate: 1 quart to 1 gallon per acre.

PLANTS

COTTON: 1 quart to 1 gallon per acre. Apply as needed.

TURF: Apply 6 to 24 fl ounces per 1000 sq ft as required to maintain K levels. Apply as
