DIRECTIONS FOR USE

GENERAL INFORMATION: MONTEREY FLUID FERTILIZER 8-6-12 is recommended for use on, but not limited to, vegetable and row crops, deciduous fruit and nut trees, citrus, avocados, vine and berry crops, ornamentals, turf, pasture and range grasses.

MONTEREY FLUID FERTILIZER 8-6-12 may be used at any time to correct plant nutrient deficiencies and maintain healthy growth. Rates are recommended below, but may vary depending on crop conditions and cultural practices.

COMPATIBILITY: MONTEREY FLUID FERTILIZER 8-6-12 may be applied separately or in conjunction with most other fertilizers. This product is compatible with most acid based fertilizers and other plant nutrients. However, a compatibility test is recommended if the desired combination has not been previously used.

FOLIAR APPLICATIONS

CROPS: Apply 1-2 quarts per acre in enough water for thorough coverage, but avoid excessive run off. After initial application, monitor petiole nutrient levels and apply at 10-14 day intervals or as needed.

TURF: Apply 3-6 fl.oz. per 1,000 square feet in a minimum of 10 gallons of water.
