DIRECTIONS FOR USE

GENERAL INFORMATION: MONTEREY ST-K contains two primary plant nutrients and is designed to correct potassium deficiencies. This product is designed for easy mixing with water and applied through fertilizing equipment or injected into irrigation systems.

This product has a low salt index, so it is ideal for use in planter band and foliar applications. MONTEREY ST-K will quickly boost plant growth during critical or high growth periods and can help prevent damage due to weather.

MONTEREY ST-K is recommended for use on, but not limited to, vegetable and row crops, deciduous fruit and nut trees, citrus, avocados, vine and berry crops, ornamentals, turf, pasture and range grasses.

COMPATIBILITY: MONTEREY ST-K may be applied separately or in conjunction with most other fertilizers. This product is compatible with most acid based fertilizers and other plant nutrients. However, a compatibility test is recommended if the desired combination has not been previously used.

Use only stainless steel or poly pumps, fittings and hoses. Use of any other type of equipment may result in damage to the handling system.

APPLICATION METHOD: Soil applications of MONTEREY ST-K can be incorporated in liquid fertilizer or applied separately. This product is most effective when applied through an irrigation system or banded. If using center-pivot irrigation equipment, use only with electric or oil hydraulic drive systems that provide a uniform water distribution.

MIXING: Add MONTEREY ST-K to a partially filled tank and slowly add the remaining water while maintaining constant agitation. Always add this product to the spray tank before adding other agricultural chemicals.

APPLICATION RATES: Apply 2 to 10 gallons per acre of MONTEREY ST-K mixed with compatible fertilizers. To use MONTEREY ST-K alone, apply the following rates if you do not have a soil or leaf analysis:

Mild Deficiency 2-6 gals./acre
Moderate to
Severe Deficiency 6-10 gals./acre
After initial application, monitor petiole potassium levels and apply again as needed.
