SECTION 3 - HAZARDS IDENTIFICATION SUMMARY

(As defined by OSHA Hazard Communication Standard, 29 CFR 1910.1200)

HEALTH HAZARDS: Harmful if swallowed, inhaled or absorbed through skin. Moderate eye irritant.

PHYSICAL HAZARDS: May release toxic fumes if burned.

ENVIRONMENTAL SUMMARY: Propazine is slightly toxic to fish. Use with care when applying to areas frequented by wildlife or near any body of water. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not apply when conditions favor drift from target area. Do not contaminate water when disposing of equipment washwaters. Do not contaminate water used for irrigation or domestic purposes.
