3: HAZARDS IDENTIFICATION

Symptoms of Acute Exposure

Causes eye, skin and respiratory passage irritation. May cause allergic skin reactions. Exposure to high vapour levels may cause headache, drowsiness and dizziness.

Hazardous Decomposition Products

Can decompose at high temperatures forming toxic gases.

Physical Properties

Appearance: Light to dark brown liquid.

Odour: Aromatic solvent.

Unusual Fire, Explosion and Reactivity Hazards

Combustible liquid. Can release vapours that form explosive mixtures at temperatures at or above the flash point. Heavy vapours can flow along surfaces to distant ignition sources and flash back. During a fire, irritating and possibly toxic gases may be generated by thermal decomposition or combustion.

Potential Health Effects

4: FIRST AID MEASURES

IF POISONING IS SUSPECTED, immediately contact the poison information centre, doctor or nearest hospital. Have the product container, label or Material Safety Data Sheet with you when calling IPCO, a poison control center or doctor, or going for treatment. Tell the person contacted the complete product name, and the type and amount of exposure. Describe any symptoms and follow the advice given.

EYE CONTACT: Flush eyes with clean water, holding eyelids apart for a minimum of 20 minutes. Remove contact

lenses, if present, after 5 minutes, then continue rinsing eye. Call IPCO, a poison control center

or doctor for treatment advice. Obtain medical attention immediately if irritation persists.

SKIN CONTACT: Immediately remove contaminated clothing and wash skin, hair and fingernails thoroughly with

soap and water. Flush skin with plenty of water for 15-20 minutes. Call IPCO, a poison control

There is no specific antidote if this product is ingested. Treat symptomatically. Contains petroleum distillate - vomiting may cause aspiration pneumonia.

MEDICAL CONDITIONS KNOWN TO BE AGGRAVATED: Pre-existing eye, skin and respiratory disorders may be aggravated by exposure to this product.

<u>5: FIRE FIGHTING MEASURES</u>

Flash point and method: 62 °C (PM CC).

Upper and lower flammable (explosive) limits in air: Lower: 1.0% Upper: 7.0%

Auto-ignition temperature: 510 °C.

Flammability: Flammable liquid.

Hazardous combustion products: Oxides or carbon and smoke are likely. Also toxic fumes of Cl^{-} and NO_x from decomposition of active ingredients.

Unusual Fire, Explosion and Reactivity Hazards: Combustible liquid. Can release vapours that form explosive mixtures at temperatures at or above the flash point. Heavy vapours can flow along surfaces to distant ignition sources and flash back. During a fire, irritating and possibly toxic gases may be generated by thermal decomposition or combustion.

Conditions under which flammability could occur: This product contains aromatic hydrocarbon. Temperatures above the flash point. Keep fire exposed containers cool by spraying with water.

Extinguishing media: Use water fog or mist, (avoid excess water), foam, carbon dioxide, dry powder or halon extinguishant. Wear full protective clothing and self-contained breathing apparatus. Evacuate nonessential personnel from the area to prevent human exposure to fire, smoke, fumes or products of combustion. Prevent use of contaminated buildings, area, and equipment until decontaminated. Water runoff can cause environmental damage. Contain run-off water with, for example, temporary earth barriers.

Sensitivity to explosion by mechanical impact: Not sensitive.

Sensitivity to explosion by static discharge: Low.

6: ACCIDENTAL RELEASE MEASURES

Personal Precautions: Make sure all personnel involved in the spill cleanup follow good industrial hygiene practices. A small spill can be handled routinely. Wear suitable protective clothing and eye protection to prevent skin and eye contact. Use adequate ventilation and wear equipment and clothing as described in Section 8 and/or the product label.

Procedures for dealing with release or spill: Control the spill at its source. Contain the spill to prevent from spreading or contaminating soil or from entering sewage and drainage systems or any body of water. Clean up spills immediately, observing precautions outlined in Sections 7 and 8. Pump or scoop large amounts of liquid into a disposable container. Absorb remaining liquid or smaller spills with clay, sand or vermiculite. Scoop or sweep up material and place into a disposal container. Wash area with detergent and water. Pick up wash liquid with additional absorbent and place into compatible disposal container. On soils, small amounts will naturally decompose. For large amounts, skim off the upper contaminated layer and collect for disposal. Once all material is cleaned up and placed in a disposal container, seal container and arrange for disposal. Spillages or uncontrolled discharges into watercourses must be reported to the appropriate regulatory authority.

7: HANDLING AND STORAGE

Handling practices: KEEP OUT OF REACH OF CHILDREN. Prevent eating, drinking, tobacco use, and cosmetic application in areas where there is a potential for exposure to the material. After work, rinse gloves and remove protective equipment, and wash hands thoroughly with soap and water after handling, and before eating, tobacco use, drinking, applying cosmetics or using the toilet. Wash contaminated clothing before re-use and separate from household laundry. Keep containers closed when not in use. Protect product, wash or rinse water, and contaminated materials from uncontrolled release into the environment, or from access by animals, birds or unauthorized people.

Appropriate storage practices/requirements: Store in original container only in a well-ventilated, cool, dry, secure area. Protect from heat, sparks and flame. Do not expose sealed containers to temperatures above 40 °C. Keep separate from other products to prevent cross contamination. Rotate stock. Clean up spilled material immediately.

8: EXPOSURE CONTROLS/PERSONAL PROTECTION

Applicable control measures, including engineering controls: Ensure work areas have ventilation, containment, and procedures sufficient to maintain airborne levels below the TLV. Warehouses, production area, parking lots and waste holding facilities must have adequate containment to prevent environmental contamination. Provide separate shower and eating facilities.

Personal protective equipment for each exposure route:

General: Avoid breathing vapours or aerosols. Avoid contact with eye, skin and clothing. Wash thoroughly after handling and before eating, drinking, applying cosmetics or handling tobacco.

INGESTION: Do not eat, drink, handle tobacco, or apply cosmetics in areas where there is a potential for exposure to

this material. Always wash thoroughly after handling.

EYES: Where eye contact is likely, use chemical splash goggles. Facilities storing or utilizing this material

should be equipped with an eyewash facility and a safety shower.

SKIN: Where contact is likely, wear chemical-resistant (such as nitrile or butyl) gloves, coveralls, socks and

chemical-resistant footwear. For overhead exposure, wear chemical-resistant headgear.

INHALATION: A respirator is not normally required when handling this substance. Use process enclosures, local

The acute toxicity test results reported in Section 11, above, for the finished product take into account any acute hazards related to the "other components" in the formulation.

Cloquintocet-Mexyl

Causes mild eye and skin irritation. May be harmful if inhaled. Allergic skin reactions are possible.

Naphthalene (< 6%)

Exposure to naphthalene can cause cataracts, liver damage, kidney failure, respiratory failure, hematuria, anemia, damage to red blood cells, leukocytosis, or coma.

Petroleum Solvent

Inhalation of vapours at high concentrations can cause central nervous system (CNS) effects (e.g. dizziness, headache, etc.), irritation to eyes or respiratory tract.

n-Methylpyrrolidone ($\leq 9\%$)

May cause respiratory tract irritation. Repeated or prolonged exposure may cause drying and cracking of the skin.

12: ECOLOGICAL INFORMATION

Summary of Effects

IPCO Legend A selectively controls certain grass weeds of cereal crops. The active ingredient, clodinafop-propargyl, is highly toxic to fish, moderately toxic to water invertebrates (water flea), but has low toxicity to birds and practically non-toxic to bees.

Environmental Fate

The active ingredient Clodinafop-propargyl is biologically degraded by microorganisms in soil or water, and is also degraded by soil hydrolysis and photolysis. It has a low bioaccumulation potential. It is not persistent in the environment, with DT50 values of less than one day in soil or natural water. The mobility in soil is low to moderate. Horizon as a bulk liquid sinks in water (24 hr observation) and gradually disperses as an emulsion.

13: DISPOSAL CONSIDERATIONS

<u>Waste disposal information</u>: Do not reuse empty containers. Empty container retains product residue. Triple rinse, or equivalent, empty container, return rinse water to dilution mixture, and dispose of dilution mixture as a hazardous waste if it cannot be disposed of by use according to label instructions. Dispose of empty containers in accordance with local regulations. Consult provincial environment ministry for advice on waste disposal. Industrial/commercial waste may be handled at licensed facilities only. Waste shipments must be securely packaged and properly labelled. Only licensed carriers may be used, and proper documents must accompany the shipment.
