## 4. FIRST AID MEASURES

### 4.1. Description of first aid measures

**4.1.1. Eye contact:** If in eyes, hold eye open and rinse slowly and gently for 15-20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing. Call a poison control center or doctor for treatment advice.

**4.1.2. Skin contact:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

## 7. HANDLING AND STORAGE

Good industrial practice in housekeeping and personal hygiene should be followed.

### 7.1. Precautions for safe handling
