### Section 4: First-Aid Measures

## Section 6: Accidental Release Measures

### **Personal Precautions:**

- Isolate area. Keep unnecessary and unprotected personnel from entering the area. Refer to Section 7, Handling, for additional precautionary measures. Keep upwind of spill. Spilled material may cause a slipping hazard. Ventilate area of leak or spill. Use appropriate safety equipment.
