SECTION VII: HEALTH HAZARD DATA

HEALTH HAZARDS: May be irritating to the nose and respiratory tract. Skin irritation may result from repeated or prolonged exposure. May also be irritating to the eyes. Ingestion may result in abdominal pain, nausea, and diarrhea. Excessive exposure to the active ingredient may produce organophosphate-type cholinesterase inhibition. Signs and symptoms may include headache, dizziness, incoordination, muscle twitching, tremors, sweating, pupil constriction, blurred vision, salivation, tearing, tightness in the chest, excessive urination, and convulsions.
