Spotted Wing Drosophila (adult)	2.4 – 2.8	Apply as a foliar spray, targeting adult growth stage. Reapply as necessary but no closer than a 14-day interval.

Maximum LEVERAGE 360 allowed per 14-day interval: **2.8 fluid ounces/A (0.022 lb AI/A β -cyfluthrin, 0.044 lb AI/A imidacloprid)**

Maximum LEVERAGE 360 allowed per crop season: **5.6 fluid ounces/A (0.044 lb AI/A β -cyfluthrin, 0.088 lb AI/A imidacloprid)**
