#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Follow all applicable directions, restrictions and precautions on the federally-registered label.

This label must be in the possession of the user at the time of pesticide application.

This Supplemental Label contains new or supplemental instructions for use of this product which do not appear on the package material. Follow the instructions carefully. #### REDUCED PREHARVEST INTERVAL IN ALMOND

**Application Methods:** Apply by ground, chemigation, flood, flooded basin, and gravity flow irrigation systems.

#### **Use Methods, Timings and Use Rates**

Apply **Satellite HydroCap Herbicide** either in a single application or sequentially with an interval of 30 days or more. Apply between **2.0 to 6.3 quarts per acre** depending on the grower's weed control program, level of weed infestation, and desired use strategy (see following chart). Do not exceed a total of 6.3 quarts/A per year in almond trees.

Satellite HydroCap Herbicide Use Rate per Acre

Low Use Rate	High Use Rate
2.0 quarts	4.0 to 6.3 quarts

#### **Ground Applications (Bearing)**

Use Satellite HydroCap Herbicide as a surface incorporated or (surface) preemergence application.

Apply as a broadcast or banded treatment using ground equipment before weed germination. Apply the spray directly to the ground beneath the trees and/or in areas between rows. **DO NOT** apply over the top of trees with leaves or buds or fruit. Contact by the spray mixture with leaves, shoots, or buds may cause injury.

#### **Chemigation Applications**

Apply **Satellite HydroCap Herbicide** through sprinkler irrigation and drip irrigation systems. Follow all directions, special instructions and precautions about chemigation in the **Spraying Instructions** section of the **Satellite HydroCap Herbicide** container label. **DO NOT** apply **Satellite HydroCap Herbicide**-treated irrigation water over top of trees with leaves or buds or fruit. Contact with leaves, shoots, or buds by spray mixture may cause injury.

#### Flood, Flooded Basin, and Gravity Flow Irrigation Systems

Apply **Satellite HydroCap Herbicide** in flood, flooded basin, and gravity flow irrigation systems. Follow all directions, special instructions and precautions about flood, flooded basin, and gravity flow irrigation systems in the **Spraying Instructions** section of the **Satellite HydroCap Herbicide** container label.



## Supplemental Label

#### **Restrictions and Limitations**

- DO NOT apply more than 6.3 quarts of Satellite HydroCap Herbicide per acre per year in almond trees.
- DO NOT apply by air.
- **DO NOT** feed forage or graze livestock in treated groves or orchards.
- DO NOT apply within 60 days before harvest of almonds.
- DO NOT apply to newly seeded nursery stock.
