Product Information

Outlook is a selective residual herbicide for controlling many annual grasses, annual broadleaf weeds, and sedge as they germinate. Emerged weeds will not be controlled and must be controlled with an appropriate postemergence herbicide. Refer to **Table 1** on the **Outlook** container label for a complete list of weeds controlled.

Application Information

Outlook may be used as part of a weed management program in baby (first year planting) and mature hops. Outlook may only be applied by ground (banded) application (including postemergence-directed). Apply Outlook preemergence to weeds when hops are in the

dormant or early vegetative stages of growth. Incorporate **Outlook** as soon as possible after application for maximum weed control.

Outlook may only be applied in a single application.

DO NOT apply **Outlook** within 60 days of harvest of hops.

Outlook has not been tested on hops grown in all soil textures. Refer to **Table 2** on the **Outlook** container label for soil texture group descriptions. BASF recommends testing **Outlook** on a small portion of the target crop to confirm safety in the local soil type.

The maximum **Outlook** application rates in a single application are 12 to 18 fl ozs/A on coarse-texture soils and 14 to 21 fl ozs/A on medium-texture or fine-texture soils.
