Important: Do not apply Dual MAGNUM by irrigation for crops on this label.

LIMA BEAN

Apply Dual Magnum preplant, preplant incorporated, or preemergence for control or suppression of yellow nutsedge, annual grasses, and small-seeded broadleaves. In general, the risk of crop injury from the use of Dual Magnum Herbicide is greater from preplant incorporated than from preplant non-incorporated or preemergence applications. Rainfall or irrigation immediately following Dual Magnum application will increase the risk of crop injury

Dual Magnum use rates in lima beans:

Soil Type	<3% OM	≥3%OM
Coarse	1-1.33 pt/A	1.33 pt/A
Medium	1.33-1.67 pt/A	1.33-1.67 pt/A
Fine	1.33-1.67 pt/A	1.67-2.0 pt/A

Split application

Dual Magnum may also be applied as a split application where ½ of the use rate is applied preplant, preplant incorporated or preemergence and the other ½ use rate is applied as a row middle treatment with a hooded or shielded sprayer prior to initiation of pods. Lima beans treated under the split application method can be harvested at normal timing.

Restrictions:

- 1. Do not apply more than 2.0 pts./A of Dual Magnum during any one crop year
- 2. Do not cut hay within 120 days following a Dual Magnum application.
- 3. Do not use for forage within 60 days following a Dual Magnum application.
