Eyespot ( <i>Aureobasidium zeae</i> )	

**Notes and Restrictions:** Apply Stratego YLD Fungicide as a broadcast foliar spray at V4 (four leaf collar) to V7 (7 leaf collar) growth stages when conditions are favorable for disease development. For season-long control of these and other diseases listed on the label, such as gray leaf spot and rust, apply a sequential treatment of Stratego YLD Fungicide at 4 to 5 fluid ounces per acre from growth stages VT through R2 (full tassel through blister).

Stratego YLD Fungicide may be applied by ground, air or chemigation.

Do not apply more than 10 fluid ounces of Stratego YLD Fungicide per acre per season. Do not apply within 14 days of harvest for grain and fodder. Forage may be harvested the same day of application.

Do not apply more than 2 sequential applications of Stratego YLD Fungicide.
