Eggplant, Okra, Pepper (Bell & non-Bell)	Brown Marmorated Stinkbug	7.1 to 10.3 fl oz/A (0.07 to 0.1 lb ai/A)

**DIRECTION FOR USE:** Apply 7.1 to 10.3 fl oz/A (0.07 to 0.1 lb ai/A) HERO insecticide by ground or air equipment using sufficient water to obtain full coverage of foliage (minimum of 15 gallons finished spray per acre by ground and 2 gallons per acre by air). Thorough coverage is essential to achieve control. Timing and frequency of applications should be based upon insect populations reaching locally determined economic threshold levels. Apply as required by scouting. Under heavy outbreak conditions tank mixing with another insecticide or use of HERO in a sequential insecticide program with an insecticide labeled for this insect pest is recommended.

**RESTRICTIONS:**

- Do not apply more than 10.3 fluid ounces of product (0.1 pound active ingredient) per acre per application.
- Do not apply more than 27.39 fluid ounces of product (0.266 pound active ingredient) per acre per season.
- Do not make applications less than 7 days apart.
- Do not harvest eggplant, okra, or peppers within 7 days of an application.
- Do not make aerial or ground applications to eggplant, okra, peppers if heavy rainfall is imminent.
