ECOLOGICAL PROFILE

FlyAway[®] spray will not contaminate food or water sources. FlyAway[®] will not contaminate soil and will decompose over time into organic matter. FlyAway[®], in its diluted form has shown to be non-toxic to humans, domestic animals, birds, and livestock. FlyAway[®] has been tested for aquatic toxicity and results indicate that it will not cause harm to the aquatic environment. FlyAway[®] will not contaminate water through drift of spray or runoff.

DIRECTIONS FOR USE

FlyAway[®] is ideal for use in misting system and is adaptable to any system. Adjust number of pulses per day according to insect pressure. Under normal conditions use 6 to 8 pulses, each 20 to 30 seconds in length. This product targets all generations of insect development killing eggs, larvae and adults. Livestock usually enjoy the spray as it kills any mites or eggs on their coats or skin.

MIXING INSTRUCTIONS

Each 25 ounce bag of FlyAway[®] makes 50 gallons of finished product. Mix the contents of the bag by hand prior to opening, then cut a corner off the top of the bag and slowly pour the contents of the bag into 25 gallons of water while agitating the water. Make sure that the pH of the water is between 6.0 to 7.0. An ideal agitator is a cordless power drill with a paint mixer attachment. Put the head of the paint mixer 8" - 12" under the water and pour the concentrate into the venturi created by the head of the paint mixer. The solution will be perfectly blended and once will not settle.

PRODUCT PERFORMANCE TIMELINE

FlyAway[®] is designed to kill insects as well as break the breeding cycle by killing eggs and larvae that are laid in surrounding areas and in manure. It takes 5 to 6 days to effectively stop this cycle. To see best results of misting FlyAway[®] allow approximately one week of applications.

WARNINGS

If a misting system has been using a pyrethrum based solution there may be some brown sticky residue remaining in the lines and spray heads. FlyAway[®] may cause this residue to break away and could cause the heads to clog. It is easy to remove this material by cleaning this residue from any clogged heads. After a short time of using FlyAway[®] the system will be clean as the product will NOT clog when used correctly. The product is water soluble and can easily be blown out of a system using plain water even after sitting over a winter with out use.

FlyAway[®] ingredients meet the Program Standards set forth by the National Organic Program (NOP) final rule 7CFR Part 205.
