#### SPECIAL CONDITIONS AND WAIVER OF LIABILITY FOR USE

##### Dow AgroSciences Intends for this Supplemental Labeling to be Used Only by Chili Pepper Crop Owners in Texas

Dow AgroSciences intends that this supplemental labeling and product be distributed only to crop owners or their agents who agree in writing to terms and conditions of use described in a Waiver of Liability Certificate provided separately. Dow AgroSciences and the Texas Department of Agriculture and Advisory Committee have agreed that the Waiver of Liability Certificate will be signed by the crop owner prior to use of this product. If, before use, such terms and conditions of use are found to be unacceptable, Dow AgroSciences requests that the product be returned to the seller as soon as possible, unopened.

#### Directions for Use

- It is a violation of Federal law to use this product in a manner inconsistent with its labeling.
- This labeling must be in the possession of the user at the time of application.
- Read the label affixed to the container for Treflan TR-10 herbicide before applying. Carefully follow all precautionary statements and applicable use directions.
- In additions to restrictions and limitations imposed by this supplemental labeling, use of Treflan TR-10 is subject to all use precautions and limitations imposed by the label affixed to the container for Treflan TR-10.

Apply Treflan\* TR-10\* herbicide as a postemergence incorporated treatment **when pepper plants are 5 to 7 inches tall** using ground application equipment. Destroy existing weeds by cultivation before applying. Treflan TR10 does not control existing weeds.

**Treflan TR-10:** Apply as a postemergence incorporated treatment using ground broadcast equipment that will uniformly and accurately apply Treflan TR-10 to the soil surface. Do not apply when plants are wet from dew or irrigation. Prolonged foliar contact with Treflan granules under wet conditions may result in foliar crop injury.

#### Broadcast Application Rates:

Soil Texture	Treflan TR-10 (pounds/acre)
Coarse	3.75 - 5.0
Medium	5.0 - 7.5
Fine	7.5 - 10.0

**Incorporation Directions:** Incorporate Treflan TR-10 within 24 hours using one pass of a sweep-type or rolling cultivator. Operate sweep-type or rolling cultivator at 6 to 8 mph to provide optimal soil mixing and move treated soil into the crop row. Sweep-type cultivators should have 3 to 5 sweeps per middle. Adjust incorporation equipment to prevent mechanical injury to the crop.

# WAIVER OF LIABILITY CERTIFICATE

I, the undersigned, acknowledge and understand that Dow AgroSciences (1) does not assume any liability for the use of Treflan\* TR-10\* herbicide for broadleaf weed control in chili peppers and (2) makes no representations regarding its weed control or crop safety when applied in chili peppers.

I hereby release Dow AgroSciences, the Texas Department of Agriculture and Pesticide Advisory committee, and the Seller from whom I purchased Treflan TR-10, their owners, officers, employees and agents, from any and all losses, damages, claims or causes of action, including reasonable attorney's fees and costs, relating to damage to or loss of any chili pepper crop resulting from use of Treflan TR-10 whether used by me or my agent. I further agree that I will not provide this product to any third party for use in chili peppers. If this provision is violated, I will indemnify Dow AgroSciences, the Texas Department of Agriculture and Pesticide Advisory committee, and the seller from whom I purchased Treflan TR-10, their owners, officers, employees and agents, from any and all losses, damages, claims or causes of action, including reasonable attorney's fees and costs, relating to damage or to loss of any chili pepper crop resulting from use of Treflan TR-10 by any third party.

I agree that I will not apply Treflan TR-10 in chili peppers without first signing and executing this Waiver of Liability Certificate.

I warrant and represent that I have sole interest in the crop to be treated or am authorized to act on behalf of and bind all parties with an interest in such crop.

I have read this Waiver of Liability Certificate and have had the opportunity to have it reviewed by an attorney of my choosing. If the terms and conditions of this Waiver of Liability Certificate are unacceptable, Dow AgroSciences requires that the product be returned to the seller as soon as possible, unopened.
