Treflan for Dodder Control in Established Alfalfa Grown for Seed

ATTENTION

- Use of Treflan TR-10 according to this supplemental labeling is subject to all use precautions and limitations imposed by the label affixed to the container for Treflan TR-10.

Directions for Use

Treflan* TR-10* herbicide is registered for general weed control in established alfalfa at up to 20 pounds per acre. Under this Special Local Need Registration, Treflan TR-10 may be surface applied in established alfalfa grown for seed only at 30 to 40 pounds per acre. When Treflan TR-10 is applied at more than 20 pounds per acre, alfalfa seed must not be used for human or animal consumption and use of alfalfa forage, hay or seed byproducts for food or feed is prohibited (see "Use Restrictions").

Application Directions

Apply at a broadcast rate of 30 to 40 pounds per acre in late winter or spring. Application and activation must occur before dodder germination. For best results Treflan TR-10 should be activated within 3 days after application. When surface applied, Treflan TR-10 may be activated by rainfall, overhead sprinkler irrigation, flood irrigation, furrow irrigation or by mechanical incorporation. If activated using furrow irrigation the surface of beds between furrows should be thoroughly wetted. When mechanically incorporated use incorporation equipment that will insure thorough soil mixing and cause minimum damage to established alfalfa.

Use Restrictions:

- Do not graze or cut alfalfa for hay or forage following a Treflan TR-10 application of **more than 20 pounds per acre**.
- Do not use harvested seed for sprouting. Processed seed must be labeled "**Not for Human or Animal Consumption**" at the processing plant.
- All seed screenings from alfalfa treated with more than 20 pounds per acre Treflan TR-10 must be disposed of in such a way that they cannot be recovered and utilized for food and feed.

Use Precautions

- Where alfalfa is to be rotated to another crop in the season following application of Treflan TR-10, plant only those crops to which Treflan herbicide may be applied as a preplant incorporated treatment or crop injury may occur. Read and carefully follow all rotational crop restrictions on the label for Treflan TR-10. The potential for rotational crop injury may be reduced by moldboard plowing to a depth of 12 inches prior to planting.
- Do not apply to seedling alfalfa (up to 6 true leaf stage).
