**NOTE:** Additional use restrictions listed below apply to the following Florida counties: Brevard, Charlotte, Citrus, Collier, DeSoto, Glades, Hardee, Hendry, Hernando, Highlands, Hillsborough, Indian River, Lake, Lee, Manatee, Martin, Monroe, Okeechobee, Orange, Osceola, Palm Beach, Pasco, Pinellas, Polk, Sarasota, Seminole, St. Lucie, Sumter, and Volusia. Use of Telone EC is prohibited in Broward and Dade counties. For all other Florida counties, follow the label affixed to product container for Telone EC.

### Additional Use Restrictions

- Use Telone EC only on soils that have a relatively shallow hard pan or soil layer restrictive to downward water movement (such as spodic horizon) within six feet of the ground surface and are capable of supporting seepage irrigation regardless of irrigation method employed.
- Do not apply where subsurface drip irrigation equipment might release the fumigant directly into shallow subsurface irrigation water.
- For use only by applicators who have a Restricted Use Pesticide license.
