#### GENERAL INFORMATION

Do not apply this product through any type of irrigation system.

Esteem 0.86 EC is intended for use in Insect Pest Management (IPM) or Insect Resistance Management (IRM) programs. Esteem 0.86 EC will not control insect adults, and it is recommended to be used in combination and/or rotation with other IPM or IRM materials. Contact your local state extension service for details.

#### RESISTANCE MANAGEMENT RECOMMENDATIONS

For resistance management purposes, *Esteem* 0.86 EC is a Group 7D insecticide. Any insect population may contain individuals naturally resistant to *Esteem* 0.86 EC and other Group 7D insecticides. The resistant individuals dominate the insect population if these insecticides are used repeatedly. These resistant insects may not be controlled by *Esteem* 0.86 EC or other Group 7D insecticides, although local experts should be consulted for local resistance recommendations. The classification scheme is based on mode of action. It is recognized that resistance of insects and mites to insecticides and acaricides can also result from enhanced metabolism, reduced penetration or behavioral changes that are not linked to any site of action classification but are specific for individual chemicals or chemical groupings. Despite this, alternation of compounds from different chemical classes remains a viable management technique.

To delay insecticide resistance

- Avoid exclusive repeated use of insecticides from the same chemical subgroup.
- Integrate other control methods (chemical, cultural, biological) into insect control programs.
