DIRECTIONS FOR USE

It is a violation of Federal law to use this product in any manner inconsistent with its labeling.

This label must be in the possession of the user at the time of the herbicide application.

See “GENERAL INFORMATION” and “MIXING” sections of the label booklet for essential product information.

EXTREME CARE MUST BE EXERCISED TO AVOID CONTACT OF THE SPRAY WITH FOLIAGE, GREEN STEMS, OR FRUIT OF DESIRABLE CROPS, PLANTS, TREES OR OTHER DESIRABLE VEGETATION, SINCE SEVERE DAMAGE OR DESTRUCTION MAY RESULT.

USE INSTRUCTIONS: This product may be applied by ground equipment prior to harvest of garlic that is grown for dehydration only. Application should be made after the last irrigation and before removing the top growth of the crop. Application of 22 to 44 ounces of this product diluted with water into 5 or more gallons of spray solution per acre will suppress or control field bindweed and yellow nutsedge.

PRECAUTIONS, RESTRICTIONS: Before application ensure that garlic plant tops have fully dried down and there is no green tissue present. Allow a minimum of 30 days between application and harvest. Preharvest application to garlic grown for seed is not recommended, as a reduction in germination or vigor may occur. Do not make aerial applications at a preharvest timing to garlic.

Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 4 hours.

NOTE: Application of this product when green plant tissue is present can lead to a deterioration of crop quality.

Read the “LIMIT OF WARRANTY AND LIABILITY” in the label for Roundup WeatherMAX herbicide before using this product. Those terms apply to this supplemental labeling and if those terms are not acceptable, return the product unopened at once.
