ENVIRONMENTAL HAZARDS

This pesticide is toxic to mammals, fish and aquatic invertebrates. Do not apply directly to water, or areas where surface water is present or to intertidal areas below the mean high water mark. Runoff may be harzardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment washwater or rinsates.

Ground Water Advisory: Tebuconazole is known to leach through soil into ground under certain conditions as a result of label use. Use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in ground-water contamination.

Surface Water Advisory: This product may contaminate water through drift of spray in wind. This product has a high potential for runoff for several months or more after application. Poorly draining soils and soils with shallow water tables are more prone to runoff that contains this product. Notes and Restrictions:

- Apply TEBUSTAR 3.6 FL in a minimum of 10 gallons of spray solution per acre by ground sprayer or in a minimum of 5 gallons of spray solution per acre by aircraft spray equipment.
- A maximum of 4 fl. oz. of TEBUSTAR 3.6 FL may be applied per acre per crop season.
- Do not apply within 30 days of harvest. Straw cut after harvest may be fed or used for bedding.
- Grazing livestock or feeding of green forage is permitted 6 or more days after the last application of TEBUSTAR 3.6 FL.
- Barley fields should be observed closely for early disease symptoms, particularly when susceptible varieties are planted and/or under prolonged conditions favorable for disease development.

Application Timing Directions:

- Rusts: Apply at the earliest sign of rust pustules on foliage.
- Fusarium head blight: Optimal timing for head blight suppression is when main stem heads have fully emerged (Feekes 10.5) on 50% of the plants.

General Comments:

- For optimum disease control, the lowest specified rate of a spray surfactant should be tank-mixed with TEBUSTAR 3.6 FL.
- TEBUSTAR 3.6 FL must have 2 4 hours of drying time on plant foliage for the active ingredient to move systemically into plant tissue before rain or irrigation occurs. After this period of time, TEBUSTAR 3.6 FL will be resistant to weathering.
- TEBUSTAR 3.6 FL is a demethylation inhibitor (DMI) fungicide (Group 3).

- Wheat fields should be observed closely for early disease symptoms, particularly when susceptible varieties are planted and/or under prolonged conditions favorable for disease development.
- Apply TEBUSTAR 3.6 FL in a minimum of 10 gallons of spray solution per acre by ground sprayer or in a minimum of 5 gallons of spray solution per acre by aircraft spray equipment.
- A maximum of 4 fl. oz. of TEBUSTAR 3.6 FL may be applied per acre per crop season.
- Do not apply within 30 days of harvest. Straw cut after harvest may be fed or used for bedding.
- Do not allow livestock to graze or feed green forage to livestock prior to 6 days after treatment with TEBUSTAR 3.6 FL.
- Barley fields should be observed closely for early disease symptoms, particularly when susceptible varieties are planted and/or under prolonged conditions favorable for disease development.

Application Timing Directions:

- Rusts: Apply at the earliest sign of rust pustules on foliage.
- Fusarium head blight: Optimal timing for Fusarium head blight suppression is the beginning of flowering on main stem heads (Feekes 10.51).
