Complete coverage must be assured to achieve maximum control.

Do not make ground applications within 25 feet of aquatic habitats (such as, but not limited to, lakes, reservoirs, rivers, permanent streams, marshes, natural ponds, estuaries, and commercial fish ponds).

DIRECTIONS FOR USE: (Cont'd)

Wind speed must be measured adjacent to the application site on the upwind side, immediately prior to application. Only apply this product if the wind direction favors on-target deposition. Do not apply when the wind velocity exceeds 15 mph.

For airblast applications, turn off outward pointing nozzles at row ends and when spraying the outer two rows. To minimize spray loss over the top in orchard applications, spray must be directed into the canopy.

Always read and follow all label directions when using pesticides alone or in tank-mix combinations. The most restrictive labeling applies when using a tank-mix. Refer to the Mustang Insecticide Federally Registered product label for additional restrictions and use directions.

RESTRICTIONS:

Do not make applications less than 14 days apart.
