Complete coverage must be assured to achieve maximum control.

Do not make aerial applications within 150 feet of aquatic habitats (such as, but not limited to, lakes, reservoirs, rivers, permanent streams, marshes, natural ponds, estuaries, and commercial fish ponds).

Wind speed must be measured adjacent to the application site on the upwind side, immediately prior to application. Only apply this product if the wind direction favors on-target deposition. Do not apply when the wind velocity exceeds 15 mph.
