GENERAL INFORMATION

For control of several weeds in St. Augustinegrass lawns, including creeping charlie, cudweed, mare's tail, ragweed and spanishneedles.

For Professional Use Only:

Apply 43 ml of AAtrex 4L in 1-1.5 gals. of water per 1,000 sq. ft. of treated area. Application may be hand-carried sprayer or from truck-mounted sprayer with hose and nozzle attached. Application rate is 2.0 lbs. of active ingredient per acre of treatable area.

<u>Precaution</u>: St. Augustinegrass establishment may be delayed if application is made prior to or within 2 weeks following sprigging.

This product could cause serious injury or even death to some annual plants and woody ornamentals. Therefore, **DO NOT** apply in flower beds or closer than the drip-line of ornamentals (root zone). **DO NOT** apply during hot summer days.
