### IDLE SEASON FALLOW GROUND TREATMENT (JUNE THROUGH SEPTEMBER) FOR SUPPRESSION OF YELLOW AND PURPLE NUTSEDGE.

For best results, prior to EPTAM 20-G application soil must have enough sub-surface moisture to initiate tuber sprouting. Allow 10-14 days for tuber sprouting to occur followed by a light tillage to destroy shoots and dry the soil surface. Apply 15 to 30 pounds of EPTAM 20-G per acre as a broadcast application and incorporate immediately to a depth of 2-3 inches. Drag a heavy pipe or other leveling device behind the incorporation equipment to leave soil surface as smooth as possible. To provide maximum suppression no additional traffic through the field should take place for the entire fallow period. Rainfall or other surface disturbance will result in poor nutsedge suppression. To avoid injury to following crops, irrigate at least 30 days prior to planting. Do not plant cotton or crops not listed on the EPTAM 20-G label for 90 days after application.

All applicable directions, restrictions, and precautions on the EPA-registered label are to be followed.

This labeling must be in the possession of the user at the time of pesticide application.
