This is a recommendation of FIFRA Section 2(ee) as it relates to the use of Warrior II with Zeon Technology Insecticide for the suppression of the insect pest, Garden Symphylan (*Scutigerella immaculate*). The user must refer to the federally approved label for Warrior II with Zeon Technology and read and follow all directions for use, restrictions, and precautions.

DIRECTIONS FOR USE

It is violation of federal law to use this product in a manner inconsistent with its labeling.

For suppression of garden symphylan (*Scutigerella immaculate*) apply 1.6 fl. oz./Acre (0.025 lb. a.i./Acre) of Warrior II with Zeon Technology insecticide as a soil-incorporated treatment prior to planting.

The total amount of Warrior II with Zeon Technology applied per acre per season and pre-harvest intervals are shown in the following table. The soil application of Warrior II with Zeon Technology must be considered when calculating the total amount of Warrior II with Zeon Technology used per acre per season (soil and foliar).

Crop*	Total lb. a.i. per acre per season	Pre-harvest Interval
Head & Stem Cole Crops	0.24 lb. a.i. (0.96 pt.)	1 day
Fruiting Vegetables	0.36 lb. a.i. (1.44 pt.)	5 days
Legume Vegetables	0.12 lb. a.i. (0.48 pt.)	7 days for edible podded and succulent shelled 21 days for dried shelled
Lettuce (Head and Leaf)	0.3 lb. a.i. (1.2 pt.)	1 day

Apply in a minimum of 10 gallons per acre using ground equipment.

The user must refer to the federally approved label and read and follow all directions for use, restrictions, and precautions.

The user should have this recommendation in its possession at the time of use.
