GENERAL INFORMATION

SuperSorb F used when planting bareroot plants, seeding, installing sod or hydroseeding, may increase the ability of the soil to hold more water. It is also used to keep roots moist when bareroot plants are being shipped or transplanted. SuperSorb F will reduce the frequency of irrigation and promote more rapid establishment and plant growth.

DIRECTIONS FOR USE

NURSERY AND GREENHOUSE

Bareroot Woody Ornamentals, Seedlings: Dip roots in a slurry of 2 level scoopfuls (enclosed) of SuperSorb F (2.5 oz wt) in 5 gals of water (1 lb in 35 gals). To mix, fill container with water, sprinkle SuperSorb F into the water.

Note: Stir mixture occasionally during use. As plants are dipped SuperSorb F particles will be removed on roots making mixture more dilute. Sprinkle 1/4 scoop of SuperSorb F into mixture as needed to maintain concentration. Absorptivity may vary depending on concentration of dissolved salts in local water supply.

Additional Suggestions: The actual number of plants that can be treated with a given volume of SuperSorb F slurry depends on the size and density of the roots. We recommend first mixing a small amount for trial purposes.

LANDSCAPE AND TURF

Sodding and Seeding: 3.5 lbs SuperSorb F per 1000 sq ft (150 lbs per acre). Incorporate dry crystals 2-3 inches into the soil when preparing soil for sodding or seeding. For sloped areas use 200 lbs per acre.

Hydroseeding: Add 12 lbs SuperSorb F to 1000 gals of hydroseed mix. Rate may vary from 6 lbs to 30 lbs per acre, depending on soil type and amount of water retention desired. Add SuperSorb F to the tank. Allow at least 10 minutes for SuperSorb F to expand BEFORE adding fertilizer.

Additional Suggestions: SuperSorb F is not a wetting agent. For faster, more uniform wetting and drainage of soils and container mixes use AquaGro wetting agents.
