

# Section 10 - Stability and Reactivity

Studies showed some increase in tumours in animals exposed to terbuthylazine at high dose levels but overall it is unlikely to be carcinogenic to humans. It can cause developmental or reproductive effects however these are generally at lower doses than maternotoxic effects and it is not genotoxic or teratogenic.

Based on the findings of the acute toxicological studies evaluated of a similar product, this product has low acute oral and dermal toxicity. It is a slight eye irritant, but not a skin irritant or sensitiser.
